**Agreement of Terms**

This membership is a monthly membership with a one-time initiation fee of \$100. All members agree to provide their credit card information to be kept on file and the card on file will be charged on the first of each month. All members agree to abide by all rules, regulations, and policies of Belmont. I understand and agree that the membership will begin on the date the form is completed and the initiation fee is paid. We understand that in the event of an infringement of this Agreement, Belmont reserves the option to revoke my membership and all rights and privileges of Belmont with no refund of any amount previously paid. The membership requires a 12 month minimum commitment and cancellation of this membership before the 12 month agreement is subject to a two-month cancellation fee and must be made in writing. The membership will renew until a cancellation request is received.

**Waiver**

All members are aware of the risk of illness or injury inherent in any golf or exercise activity. These injury risks include but are not limited to: being hit by golf balls, golf clubs, golf carts or lightning; stepping or tripping in holes or other natural indentations in the ground; injury from insects, animals, birds, or snakes; pulled muscles or other

sprains, strains or injuries. All members are participating with the express understanding that I hereby indemnify, defend, waive, and release Belmont, its employees, agents, directors, and assigns from any and all claims, costs, liabilities, expenses or judgements, including attorney's fees and court costs arising out of member and guest participation.

Belmont will be maintained to allow for normal golf activities. There is no guarantee as to the condition of the course or any amenity included in this membership. Members will have access to amenities listed in this agreement subject to availability, which is to be determined at the sole discretion of Belmont. Certain private and public events, to include First Tee Youth Programming, may dictate that the golf course, short course, putting course, or practice facilities of Belmont may be closed. Members understand and agree that nothing in this Membership Agreement shall entitle the members to any to the facilities on any day nor to any discount or refund on account of any limited access. No member is entitled to a refund or return of amounts due to damage to or condition of any aspect of the facility. Belmont shall have no liability for temporary suspension of any privileges due to maintenance, repair, construction, improvements, acts of God, inclement weather, utility disruptions or any and all other matters beyond the control of Belmont.

**Provisions**

Entire Agreement: This Agreement constitutes the full and entire Agreement between the Monthly Member and Belmont and these parties acknowledge there is no other Agreement, oral and/or written, between these parties.

Assignment: The member's rights, privileges or interests under this Agreement are only assignable to those on the agreement. Changes to assigned rights, privileges or interests must be made in writing by the individual.
